Monthly Economic and Commercial Report for Kurdistan Region of Iraq – July 2023

I. OVERVIEW:

Kurdistan Regional Government (KRG) has been making efforts to diversify its economy sources through other sectors, in particular agriculture, tourism and also to digitize public services, increase citizen satisfaction and facilitate the ease of doing business in Kurdistan. In an attempt to both diversity revenue streams, and reach self-sufficiency in food products, the KRG has placed a significant focus on the development of the farming and agriculture sector. During the past four years, potato products have increased by 200,000 tons in the Region.

II. ECONOMIC AND COMMERCIAL DEVELOPMENTS

Tourism sector: On 30 July, 2023 KRG officials in association with UNDP and US Agency for International Development (USAID) launched a reform roadmap for tourism sector. In 2022, 6 million tourists mostly domestic visited the region. The government is seeking to integrate historic sites, museums, and memorials into the tourism industry to promote Kurdistan's history and heritage. There are nearly 5,000 heritage sites in Kurdistan Region including Erbil Citadel listed by UNESCO. KRG has prepared 8 year plan to attract 20 million tourist per year.

Agriculture sector: KRG continues to develop the farming and agriculture sectors in an attempt to diversify revenue streams, strengthening its economic infrastructure, and achieve self-sufficiency in food products. The Government has been promoting this vital sector through various means by development of sustainable farming , addressing water shortage, incentive schemes, export of products like potatoes and pomegranates.

Foreign Investments: Kurdistan Region's Investment Board is planning to form a team of economics experts to attract more foreign investors , and pursue business and investment. The KRG has pledged every assistance for this purpose.

Agro-products: In an attempt to both diversity revenue streams, and reach selfsufficiency in food products, the KRG has placed a significant focus on the development of the farming and agriculture sector. During the past four years, potato products have increased by 200,000 tons in the Region.

6000 companies established during KRG's 9th Cabinet - Mr. Dara Jalil Khayat, the President of the Erbil Chamber of Commerce and Industry stated that about 6,000 new companies including 150 foreign companies were established during the

four years of the Kurdistan Regional Government's (KRG), 9th Cabinet. A new industrial zone is being built in Erbil, which will comprise about 6,000 acres for new companies to establish and operate in the future. During this period, over 780 industrial and commercial factories valued at \$1.75 billion were licensed. The KRG Cabinet has recently launched online Business Registration System to improve the business climate and facilitate investment.

Water conservation project: The Ninth Cabinet of the KRG has taken measures to combat climate change and water shortages. These measures include the construction of many ponds and dams throughout the Kurdistan Region. The Cabinet approved the construction of 41 ponds, of which 23 ponds were approved in the first phase and 14 ponds in the second phase. Four more ponds have been approved in the third phase. They have also allocated \$4.11 million dollars for irrigation and flood control projects.

Tax reform: KRG released updated figures for taxation in the Region from 2019-2022, showing increasing revenue for the government over the past two years. illegal tax exemptions have been abolished, and the tax rate has been determined using more reliable information. In 2019, tax revenue was \$478.7 million. In 2020, tax revenue decreased to \$441.6 million. In 2021, tax revenue had seen growth after an economic rebound from COVID-19, which led to revenue of \$607.5 million. In 2022, tax revenue reached its highest level of \$696.3 million.

Healthcare facilities: As per KRG's Ministry of Health report released on 31 July, 2023, there are 135 hospitals (83 public and 52 private) and 1470 health centers (41% in villages). Kurdistan Region has 8000 doctors including 1500 dentists and 22,000 nurses.

KRI's President visit to Azerbaijan: Kurdistan Region President Mr. Nechirvan Barzani visited Baku on 18 July, 2023 and discussed with Azerbaijani President Ilham Aliyev on bilateral ties in numerous sectors, including economy, investment, and culture.
