Since 2017-18 Iraq is the Largest Crude sourcing destination for India. India Imported 43 MMT of crude oil in financial year 2020-21, accounting for 22.9 % of the total crude imports. For current FY (April-Feb 2022), India imported 50.33 MMT of crude oil from Iraq, accounting for 25.6% of our total crude oil import.

- The primary sectors identified by the Mission for bilateral trade are – i) agricultural products ii) pharmaceuticals iii) ceramic/granite tiles for building construction iv) renewable energy sector v) medical tourism vi) textiles and garments vii) automotive parts viii) iron and steel products ix) higher education x) tea and coffee xi) IT service sector.
- The Mission actively engages with local business chambers and forwards all the business queries from India that it receives to these organizations to establish business linkages.
- The biggest hurdle to flourishing of bilateral business is the restrictive PRC regime for Iraqi businessmen, who are made to wait for clearance for at least a month before they could set out for India to explore business opportunities there. Ministry has been apprised of this drawback and recommendation to withdraw Iraq from this list has been made.

Latest Developments:

- India confirms its willingness to open joint lines with Iraq in the**

industrial field: The Indian government confirmed its readiness to open joint lines with Iraq in the industrial field. The National Security Adviser, Qassem Al-Araji, held a meeting in New Delhi with his Indian counterpart, Ajit Doval, during which he discussed friendship and strategic interests between Iraq and India, and ways to develop them at all levels. Indian NSA expressed his willingness to support Iraq in all fields, and to conclude memorandums of understanding and coordination between Iraqi and Indian institutions, at the political, security and military levels, as well as in the fields of energy and health. The Iraqi NSA indicated that Iraq is a peace-loving country that aspires for progress, and it is important to establish strategic partnerships between the two countries. The meeting witnessed an exchange of the two countries' vision in building a strategic relationship that serves common interests, and the Indian side announced its readiness to assume partnerships with Indian industries with their Iraqi counterparts in the fields of training, institutional building and development, and the possibility of opening joint lines with Iraq in the field of various industries.

2. **Al-Araji and Indian companies agree to hold bilateral meetings to participate in the reconstruction:** The National Security Adviser, Qassem Al-Araji, chaired a meeting with several major multi-disciplinary Indian companies in New Delhi, while an initial agreement was reached that bilateral meetings be set between these companies and the Iraqi specialized authorities, to participate in the reconstruction. Iraqi NSA a meeting with ten major multi-disciplinary Indian companies, Indian companies presented during the meeting a detailed summary of their products, and expressed its willingness to meet the requirements of the Iraqi side, whether in industries or cooperation in equipment and capacity building, and to contribute to the self-sufficiency of Iraq in all fields. Al Araji stated that an initial agreement was reached for bilateral meetings between these companies and the Iraqi specialized authorities to participate in the reconstruction, support the reform program of the Prime Minister's government, and revitalize the industry of Iraq.
3. **India asks Iraq to restore Sikh temple dedicated to Guru Nanak:** India has formally requested Iraq renovate a historic Sikh temple, or gurdwara, which was built in the memory of the faith's founder Guru Nanak who once visited Baghdad as part of his travels in the Muslim world. Iraqi National Security Adviser, Qassem Al-Araji visited Delhi in March 2023 where he met his Indian counterpart Ajit Doval. It was the first cabinet minister level visit of an Iraqi official in seven years and included talks aimed at strengthening defence ties and cooperation on counter-terrorism. The Baba Nanak Gurdwara located in Baghdad's Karkh District in Sheikh Maaruf was built at the time of Guru Nanak's visit around 1511 AD, on his way back from Makkah and Madinah. He is said to have had dialogues with prominent Sufi saints including Sheikh Bahlool Dana. The gurdwara was reportedly discovered by Sikh soldiers in the British Indian Army during the First World War. However, during the 2003 US invasion of Iraq, the shrine was looted and destroyed. In 2007 the Iraqi government expressed intentions to rebuild the gurdwara, and in 2018 a gate was erected to protect the vicinity of where the former shrine once stood. The site has been under the care of a Muslim family for generations up until it was operational. The two countries share important trade ties, with Iraq serving as India's largest oil supplier. There are also historical religious links with many Muslim Indian pilgrims visiting Najaf and Karbala annually, as well as the shrine of Sheikh Abdul Qadir Gilani in Baghdad.
4. **Iraq Wins Key Kurdish Oil Arbitration Case Against Turkey:** The International Chamber of Commerce's International Court of Arbitration decided in Iraq's favor ruling that Turkey violated a 1973 pipeline transit agreement by allowing crude from the Kurdish region to be exported through Ceyhan port without Baghdad's consent. Iraq's oil ministry welcomed an arbitration ruling in its long-running dispute with Turkey centered on crude oil exports from the semi-autonomous Kurdish region and said it would discuss

mechanisms to keep oil flowing, in a manner that guarantees exports will be sustained and international commitments met. Over 1 million barrels a day passed through the Ceyhan terminal in January, or 1% of global supplies. Baghdad exports 75,000 barrels a day through Ceyhan, while the Kurdish regional government exports about 400,000 barrels a day.

5. **Prime Minister Mr. Mohammed S. Al-Sudani Attends the Ceremony of the Final Signing of the 5th Licensing Round:** Iraq's Oil Ministry signed six oil and gas contracts on February 21, 2023 that had been awarded in its fifth licensing round in 2018. PM Sudani was present at the signing ceremony. Ministry of Oil stated that the contracts are final and binding. Their signings represent a major step forward for Iraq's plans to boost domestic energy production, diversify revenue streams, and reduce dependence on costly and unreliable gas imports from Iran. PM Al Sudani emphasized that the endeavours for the investment of the associated gas and natural gas stem from a firm determination to achieve economic reforms, which are the main focus of the government program. He said that reform in the oil sector is represented in the optimal investment of oil wealth and Iraq's entry into the global gas market is an option that we planned for and will be implemented. PM Al Sudani remarked that Iraq is seeking to reach self-sufficiency in gas within three years. The final signing of contracts for the fifth round of energy licenses relate to the development and production of six fields and exploratory blocks in border areas, which were granted to the following companies:

- Naft Khana, in Diyala: Geo-Jade Petroleum (China)
- Sindibad [Sindbad] field in Basra: [United Energy Group \(UEG\)](#) (Hong Kong)

6. **Iraq Takes Steps to Go Self-Sufficient in Medical Equipment Production:** Iraqi Prime Minister Mohammed Shia' al-Sudani inaugurated the country's National Health Factory, which is designed to contribute to government efforts to upgrade the healthcare system and localize production of medical equipment. The facility will be under the supervision of Iraq's Ministry of Health. It includes four production lines that operate to meet the needs of the Ministry of Health, such as sterilization materials and other medical supplies like sheets and surgical equipment, as well as the production of dialysis solutions and the manufacture of high-quality plastic packages of various sizes, following the internationally approved specifications and standards. The factory adds to government plans to revitalize and localize the pharmaceutical industry in Iraq to provide the domestic demand and ensure drug security and ease the burden on Iraqi citizens.
7. **Four Arab countries sign MoU to boost agricultural cooperation and trade:** Iraq, Syria, Lebanon, and Jordan on Monday signed a quadrilateral memorandum of understanding (MoU) to enhance cooperation in the agricultural sector and boost trade, promoting integration among the four nations. The MoU

covers the development and strengthening of cooperation in both plant and animal agriculture, the exchange of expertise, information, successful agricultural practices, and management of reserves and parks among the four countries. Additionally, the agreement encompasses collaboration in the areas of firefighting, climate change, rural development, agricultural guidance, production, animal health, and veterinary medicine.

8. **Iraq ratifies two ILO Conventions (ILO):** The Government of Iraq submitted to the International Labour Organization the instruments of ratification of the Social Security (Minimum Standards) Convention, 1952 (No. 102) and the Maritime Labour Convention, 2006, as amended (MLC, 2006). Iraq is the 64th member State to have ratified Convention No. 102 and the 102nd member State to have ratified the MLC, 2006. The Minister of Labour and Social Affairs of the Republic of Iraq, Mr Ahmed Jasim Al-Asadi, when depositing the instrument of ratification, declared "The ratification of Convention No. 102 by Iraq emphasizes its commitment to enshrining social security as an inherent right and to reforming national legislation and regulations to strengthen legal protection and safeguards for workers and improve the business environment. By ratifying the MLC, 2006, the most modern and comprehensive ILO maritime standard, our government reiterates its engagement to defend seafarers' rights and ensure a level-playing field for shipowners.
9. **Chinese Oil Companies Lead in Iraqi Oil Purchases for February:** Iraq's State Organization for Marketing of Oil (SOMO) announced that Chinese oil companies were the largest buyers of Iraqi oil during the month of February. Chinese companies accounted for 7 of the 35 firms that purchased oil last month. It was revealed that Indian companies ranked second with six buyers, followed by American companies with four, South Korean companies with three, and Italian, Japanese, and Greek companies with two each. The remaining buyers included one company each from the Netherlands, the United Kingdom, Russia, the United Arab Emirates, Egypt, Jordan, Kuwait, Spain, Turkey, and France. The most prominent global companies that purchased Iraqi oil include India's Hindustan Petroleum, South Korea's Kogas, China's PetroChina, the United States' ExxonMobil, the Anglo-Dutch company Shell, and Italy's Eni.
10. **Halfaya oilfield to supply two power plants in Maysan with gas:** The Oil Minister, Hayan Abdel-Ghani, accompanied by the Electricity Minister, Ziyad Ali Fadel, visited Halfaya oilfield in Maysan governorate to check the associated gas projects. There is a plan to benefit from the associated gas in oil operations with a capacity of 300 million cubic feet in Halfaya oilfield, which is one of the largest oil fields in the southeastern Iraqi governorate. Missan Oil Company (MOC), in cooperation with PetroChina, achieved important steps to reach this goal. The ministers' visit aims to check the progress achieved in the two power plants built in Maysan where MOC will supply both power plants with 160 cubic meters of gas per day. The other goal of the visit was to check the oil production in this field, which is now 350 thousand barrels per day and that the Oil Ministry is seeking to raise the production of crude oil to 400 thousand barrels per day.
11. **TotalEnergies awaits solution on \$27 bln Iraq energy deal -CEO:** The stalled agreement between Iraq and TotalEnergies over a \$27 billion energy project has yet to find a resolution. TotalEnergies agreed in September 2021 to invest in four oil, gas and renewables projects in Iraq's southern Basra region over 25 years, with an initial \$10 billion. But the deal, which Baghdad hoped would reverse the exit of oil majors from the country, has been stuck amid disputes over terms. The Iraqi Government insists the country take a 40% share in the project, which has been a key sticking point, sources said. Iraq's oil minister Hayan Abdel-Ghani said that talks between TotalEnergies and Iraq regarding the deal have reached advanced stages.

12. **Exxon Mobil continues to sell its non-strategic assets:** The American Exxon Mobil Company continued the transformation process through the latest process of withdrawing its non-strategic assets, including its investments in Iraq, by selling its share in the West Qurna / 1 oilfield. ExxonMobil Corporation continued to sell non-strategic assets and focus investment on higher-priority projects, reducing the need for more debt issuance, and supporting current dividends. Selling its share in the non-operating West Qurna- 1 oil field produced in Iraq to Pertamina Indonesia, the total liquidation of ExxonMobil has reached about \$15.6 billion since April 2019, exceeding the \$15 billion liquidation plan. Exxon Mobil seeks to sell its 32.7% stake in the West Qurna / 1 field. The West Qurna field is one of the large oil fields in Iraq. Oil was extracted from it for the first time in 1973, and it is estimated that it contains oil reserves of 24 billion barrels. During the year 2010, Iraq signed several contracts with international companies to develop its oil fields within the first and second licensing rounds, most of which focused on the southern fields. The other partners in the field are the Japanese Itochu (19.6%), the Indonesian Pertamina (10%) and the Iraqi State Oil Exploration Company (5%).
13. **Ministry of Transport: German (MAN) will open a branch in Iraq:** The Ministry of Transport is stated to purchase more than 400 trucks and tanks from international origins to strengthen the ministry's fleet, while announcing the intention of the German company (MAN) to open a branch in Iraq. The General Company for Land Transport, one of the formations of the Ministry of Transport, recently launched a campaign to strengthen its fleet by submitting a project to the Ministry of Planning to purchase 100 trucks of international origin from the investment budget for the current year.
14. **Power China's proposal to develop railways:** A delegation from Power China visited the Ministry of Transport and the General Railway Company to discuss their proposals regarding the train sector. The meeting involved a discussion on Power China's offers for the manufacturing of trains and the building of high-speed railway lines. The heads of concerned departments and experts from their company were present during the meeting.
15. **India's imports of crude oil from Russia:** India's import of Russian crude soared to a record 1.6 million barrels per day in February and is now higher than combined imports from traditional suppliers Iraq and Saudi Arabia. Iraq, whom Russia has toppled to become the largest oil source for India, supplied 9,39,921 barrels per day (bpd) oil in February while Saudi supplied 6,47,813 bpd oil.
16. **Iraqi Budget announced:** Iraqi PM, Al-Sudani announced that the total budget amounted to 197 trillion, 828 billion dinars. Al-Sudani, added that the operating budget amounted to 150 trillion, 273 billion dinars. Al-Sudani said in the press conference today. The budget granted sovereign guarantees to support the private sector in implementing strategic industrial and agricultural projects. He added that investment expenditures amounted to 47 trillion, 555 billion dinars, while the fiscal deficit amounted to 63 trillion and 275 billion dinars.
17. **Iraqi-Turkish bilateral trade:** The Istanbul Exporters' Association said Turkey has exported \$1.6 billion dollars in goods to 181 countries in the past two months, a large amount to Iraq. The report said \$100 million worth of goods was exported to Iraq. The highest number of exports to the country included poultry, animal products, grain, beans and seeds.
18. **Iraqi proposal to attract Saudi investment:** The head of Iraq's National Investment Commission, Haider Mohammad Makkiya, met with Saudi Arabia's Minister of Commerce, Majid bin Abdullah al-Qasabi to discuss economic, investment, and trade cooperation between the two countries. The talks come amid increased efforts by Iraq to attract foreign investment and diversify its economy away from oil. Saudi Arabia has also been exploring investment

opportunities in Iraq as part of its Vision 2030 plan to reduce its reliance on oil exports and expand its non-oil sectors.
